**Myrmidon Group LLC/Republika Srpska**

Myrmidon Group LLC's U.S. work on behalf of the foreign principal is focused on promoting a better understanding of the principal's economic policies and its domestic reform agenda. Since January 2012, the mandate has expanded from outreach to the business, policy, analytic, academic, non-governmental, media and investment communities to include outreach to the U.S. Congress and the U.S. Government.

A significant portion of the registrant's work focuses on providing advice on the promotion of specific economic investment opportunities in Republika Sprska to the U.S public. Our advisory work involves discussion of communications between the foreign principal and the non-governmental community, business community, media, and scholars and private-sector policy analysts in the U.S.

Additionally, some of our work is focused on the government's broader investment promotion efforts and on specific investment opportunities. This work may include attracting business groups and investors in Europe, Asia, Latin America, and the Middle East.

The registrant arranged a series of briefings and policy discussions between officials of Republika Srpska, including its President Milorad Dodik and Republika Srpska Minister of Economic Relations and Regional Development, Zeljka Cvijanovic in New York City, October 23-26, 2011.

The registrant also met with and communicated with policy analysts, journalists, academic, investors, business analysts, and advisors to candidates running for the U.S. presidency. Additional meetings were held with representatives of the Serbian-American community and Jewish community leaders. None of these additional interactions (apart from those specifically noted by name above) engaged U.S. government officials, members of Congress, or their staff.
