**Myrmidon Group LLC/Republika Srpska**

Myrmidon Group LLC's U.S. -focused work on behalf of the foreign principal is focused on promoting a better understanding of the principal's economic policies and its domestic reform agenda. Since January 2012, the mandate has expanded from outreach to the business, policy, analytic, academic, non-governmental, media and investment communities to include outreach to the U.S. Congress and the U.S. Government.

Some of the registrant's work focuses on providing advice on the promotion of specific economic investment opportunities in Republika Srpska to U.S. and international investors. Some of our advisory work involves discussion of communications between the foreign principal and the non-governmental community, business community, media, and scholars and private-sector policy analysts in the U.S.

Additionally, some of our work is focused on the government's broader investment promotion efforts and on specific investment opportunities. This work may include attracting business groups and investors in Europe, Asia, Latin America, and the Middle East. Such work is part of our overall advisory role, but is not specifically subject to FARA. In addition, our work includes an advisory role to RS in its relations with European Union members.

In January 2012, our mandate expanded to advise the government on its interactions with the U.S. government and the U.S. Congress. Since October 14, 2013, we have worked in tandem with the Republika Srpska US Office for Cooperation, Trade and Investment.
