MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is entered into this ___ day of September 2011 between Portland PR Ltd. ("Portland UK"), a United Kingdom limited company, and Portland PR Inc. ("Portland USA"), a Delaware corporation, each a "Party" and collectively the "Parties."

WHEREAS, Portland UK expects to originate opportunities to provide public relations and related services on behalf of governmental entities and political parties outside the United Kingdom and the United States ("Foreign Projects"); and

WHEREAS, when warranted, Portland UK would like to employ the personnel and other resources of Portland USA to support Portland UK's work on such Foreign Projects;

ACCORDINGLY, Portland UK and Portland USA enter into this MOU to establish the following consistent terms of engagement for support by Portland USA of Foreign Projects which Portland UK originates:

1. Scope of Work. Portland USA shall work at the direction of Portland UK to support Portland UK's work on such Foreign Projects. [Add additional language from client, if any.] Staffing and in-kind support for such assistance by Portland USA shall be determined by availability and mutual agreement.

2. Initial Foreign Project. Portland UK expects to be engaged to provide public relations and other services on behalf of the Republic of Kazakhstan (the "Initial Project").

3. Professional Fees and Expenses. Professional fees and expenses for the Initial Project, and for any subsequent Foreign Project, have yet to be determined. The Parties shall allocate revenue and expenses attributable to a Foreign Project according to their customary arrangements for shared engagements and consistent with applicable tax and other laws.

4. Duration. This MOU shall continue in force until rescinded in writing by a Party or the Parties.

5. Entire Agreement. This MOU contains the entire agreement between the Parties with regard to the Initial Project and all subsequent Foreign Projects. Any amendment or modification of this MOU shall be in writing, and executed by both Parties. Any additional Foreign Projects need not require an amendment to this MOU.
