Portland will advise, assist and represent the Embassy of the State of Qatar in the United States before the U.S. executive branch departments and agencies and before Members and staff of the U.S. Congress.

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

The registrant's activities may include communications on behalf of the Embassy of the State of Qatar with officials in executive branch departments and agencies, with members and staff of U.S. Congress, and with other individuals and organizations involved in governmental and public policy matters.

Portland will provide counsel to the Embassy of the State of Qatar on matters relating to public diplomacy, strategic communications and government relations services.

Dear Mr. MacKay:

This refers to the Services Agreement (the "Agreement") between the Embassy of the State of Qatar and Portland PR Inc., effective January 1, 2015.

Pursuant to the Agreement, this shall constitute notice that the Embassy exercises its option to renew the Agreement for one six-month term, commencing January 1, 2016.

This renewal is subject to the following:

1. The terms of the Agreement that refer to Fees and Expenses are amended to add the following:

"Notwithstanding any other provision of this Agreement: (i) the Fees payable to Portland during the period January 1 - June 30, 2016 shall be \$40,000 per month, payable monthly commencing January 1, 2016; and (ii) expenses in excess of \$1,000 per month shall not be reimbursed unless Portland receives written approval from the Embassy prior to incurring such expenses."


2. Except as expressly stated herein, nothing in this letter shall alter or amend the terms of the Agreement. Without limiting the generality of the foregoing, the Consultant and the Client reserve their respective rights under Paragraph 5 of the Agreement to terminate the Agreement without cause at any time, effective 30 days after written notice.

If these renewal terms are agreeable, please confirm by adding your signature below, and returning a


