We have determined that all activities conducted by Registrant for all foreign principals from the outset of the engagement that is the subject of the Borusan Agreement attached to Exhibit B of the Registration Statement have been and continue to be confined to those for which an exemption under Section 3 of the Act is available. Specifically, under 22 U.S.C. 613(d) (2) and 28 C.F.R. 5.304(c), all such activities are directly in furtherance of the foreign principal's bona fida commercial, industrial, or financial operations; are not directed by a foreign government or political party; and do not directly promote the public or potential interests of a foreign government or political party.
