Item 11: During this 6 month reporting period, have you engaged in any activities for or rendered any services to any foreign principal named in Items 7, 8, or 9 of this statement?

1. Provided legal advice and assistance to Sudan with regard to the following cases:
  - a. Clodfelter v. Republic of Sudan, Civ. No. 11-2118 (4<sup>th</sup> Cir., filed Jan. 17, 2012); and
  - b. Owens v. Republic of Sudan, Civ. No. 01-2244 (JDB) (D.D.C., filed Oct. 26, 2001).
  
2. Provided legal advice to the Government of Sudan regarding the failure of General Electric (GE) to comply with its contractual obligation to provide variable speed drive software to the White Nile Sugar Co., Ltd. (WNSC) sugar mill, in which the Government of Sudan is a major shareholder. We assisted in the drafting of a Letter of Intent to proceed with a settlement with GE and Uttam Sucrotech (Uttam), and a Settlement Agreement with GE and Uttam. We assisted GE in obtaining visas from the Government of Sudan for its personnel to travel to and visit the WNSC facility in White Nile State, Sudan. We assisted GE in obtaining a letter of safe passage for its personnel while in Sudan. We contacted GE on February 26, 2014, to urge GE to file a request to OFAC for a Settlement License that will permit it to complete its variable speed drive software contract.
  
3. Prepared a complaint that could be filed with the U.S. District Court for the District of Columbia in the event that the U. S. Department of State continues to list Sudan as a State Sponsor of Terrorism.
  
4. On May 16, 2013, the Office of Foreign Assets Control (OFAC) issued a guidance letter indicating that a license would be granted to a U.S. exporter for the exportation of civil aircraft equipment and spare parts to Sudan. On August 7, 2013, we applied for a license for a new company, Fisher Aviation, to be able to provide brokerage services for aircraft spare parts for exportation to Sudan. We have been informed that the application is "being processed." Meanwhile, we are obtaining lists of the spare parts that may be required from Sudan Airways, in the event that a license for Fisher aviation is issued.

5. Submitted a petition to OFAC requesting that the export and re-exportation from the United States of telecommunications equipment, computer equipment, services, and software be permitted under the Sudanese Sanctions Regulations.
6. Submitted a petition for reconsideration of the OFAC decision to deny Sudan's petition to be permitted to import railroad spare parts from the United States into Sudan.
7. Submitted a petition to OFAC for a license that would permit Sudan to establish the Sudan - United States Trade Council.
8. Undertook legal research on possible cultural exchanges, including musical concerts and a planned traveling exhibition of artifacts from the Sudan National Museum.
9. Provided legal advice regarding an International Centre for the Settlement of Investment Disputes (ICSID) arbitration case against Sudan. This case involves a claim filed by Winston & Strawn.
