

## AGREEMENT OF SERVICES

This agreement shall commence January 5th, 2012 and shall continue for twelve months ending January 4th, 2013 between the Taipei Economic and Cultural Representative Office in the United States (hereto referred to as "TECRO") and the Western Hemisphere Strategies (hereto referred to as WHS)


The parties have agreed as follows:

1. WHS agrees to represent TECRO before the U.S. Congress and the U.S. government generally.
2. In the course of its representation of TECRO, WHS agrees that it will act in conformance with all applicable United States laws and regulations.
3. WHS will provide services as outlined in the attached "Scope of Work."
4. WHS shall furnish TECRO with its analyses and interpretations of political, financial, commercial and sociological developments in the United States, and advise TECRO as to actions TECRO may take to further improve relations between the two countries.
5. WHS is required to send a copy of its monthly activity report to TECRO before the 10<sup>th</sup> day of each subsequent month. All reports, recommendations materials, analyses and other documents WHS prepares shall become the property of TECRO, and WHS hereby agree that TECRO may make use thereof, without incurring any obligation for compensation other than as set in the following paragraph. Any reports prepared by WHS to TECRO shall be considered confidential and not for distribution to any third party. On request, WHS will deliver all copies, in any form to TECRO.
6. In payment of these services WHS is to receive a monthly retainer of USD \$15,000. TECRO will assign WHS additional assignments on an as needed basis, compensation to be decided upon mutual agreement.
7. Both parties understand and agree that WHS will not engage in advocacy before U.S. Representative Mario Diaz-Balart or his staff.
8. This agreement shall be construed in accordance with and governed by the laws of the District of Columbia. Any suit against TECRO arising out of this agreement shall be filed in the United States District Court for the District of Columbia pursuant to the Foreign Sovereign Immunities Act, 28 U.S.C., Section 1602 et seq. TECRO does not waive any right it may have to sovereign immunity in that court. Service on TECRO must be made pursuant to 28 U.S.C. Section 1608 (a).

9. WHS agrees that during the term of this agreement it will not represent the government of the People's Republic of China (PRC), that is, in the state itself, or any subdivision or agency or instrumentality thereof, as those terms are defined in 28 U.S.C 1603 (a) and (b).
10. Either party may terminate this contract on 30 days written notice for any reason.

### SCOPE OF WORK

During the term of this agreement, WHS will provide Taipei Economic and Cultural Representative Office (TECRO) with the following services:

1. Introduction to and negotiations with official of the Legislative branch of the United States Government. This effort will include strategies planning to assist TECRO in maintaining continuous positive relations with the U. S. Congress.
2. Arranging meetings and appointments with members of Congress and their staffers for TECRO officials. Those appointments could include working visits to member's offices and invitations to lunch or dinner at the Twin Oaks estate or other venues.
3. Working diligently to exhort members of Congress and the United States Senate to act favorably on matters of interest and benefit to Republic of China (Taiwan).
4. Encouraging members of Congress and staffers to visit Taiwan and assisting in the arrangements for CODELs by members of Congress and the Senate to Taiwan.
5. Providing TECRO with monthly activity reports and regular assessments of current developments in the U. S. Congress and U. S. political scenes in general that would be of concern to Taiwan. Such reports would contain counsel as to how problems should be addressed.
6. Providing recommendations and advice with which will help improve relations between Taiwan and the United States.
