I performed general legal research and analysis and strategic advice for TECRO throughout his period, with emphasis on the interpretation of and legislative history to the Taiwan Relations Act of 1979, 22 USC3301 et seq.; E.O. No. 13014 of August 15, 1996; the Vienna Conventions on Diplomatic and Consular Relations; diplomatic and consular law generally; official acts immunity; sovereign immunity; and, the October 2, 1980 Agreement on Privileges, Exemptions and Immunities Between the American Institute in Taiwan and the Coordination Council for North American Affairs. I also participated as an advisor at two negotiation sessions between AIT and TECRO at AIT's headquarters (1700 N. Moore Street, Suite 1700, Arlington, VA 22209) on Thursday, March 2, 2012 and on Monday and Tuesday, September 10 and 11, 2012.

During the March and September negotiations described above, I advised TECRO in its negotiations with AIT and participated actively in the negotiations, the purpose of which is a joint AIT-TECRO endeavor to review and update the 1980 PEI agreement that is referred to in the preceding paragraph. (I personally do not consider this to be "political activity," but include it as such out of an abundance of caution and based on the advice of Ms. Heather Hunt that I should err on the side of registering. As far as I am personally concerned, these are routine policy discussions/negotiations for the mutual benefit of U.S. and Taiwan non-governmental entities.) I did not arrange, sponsor, or deliver and speeches, lectures or radio or TV broadcasts, or anything of a similar nature.
