The following is an amendment to Item 11 of the supplemental statement : During the 6 month reporting period, Registrant communicated with federal legislative officials regarding policies, legislation, and networking on behalf of the Embassy of the Republic of Korea. Information relating to the renegotiation and extension of the US-Korea Nuclear Cooperation Agreement, a proposal to allow more Visas for highly skilled Korean to work in the US, as well as a desire for the President of Korea to address a Joint Meeting of Congress was communicated.

During the 6 month reporting period, Registrant communicated with federal legislative officials regarding policies, legislation, and networking on behalf of the Taipei Economic and Cultural Representative Office (TECRO). Information relating to a dispute with the Philippine government over the Philippine Coast Guard's treatment of a Taiwanese fisherman, current trade flows between the US and Taiwan, and the desire of Taiwan to participate in the Trans-Pacific Partnership, were communicated.
