We have been asked to help facilitate visits by Ministry of Public Security and Consejo Nacional de Seguridad officials to Washington, DC and assist in preparing for and coordinating meetings with appropriate officials of the Department of Homeland Security and other security agencies. CCG provides security advisory consulting services in Panama as discussed further below and our contract is with the Consejo Nacional de Seguridad of the Republic of Panama, representation in the United State is not part of the scope of that contract. During the course of our work in Panama we were asked to assist on the visits here to the U.S. by the Ministry of Public Security and to coordinate with Panama's embassy to the United States. We are not being compensated to provide this assistance but are performing this service pro bono.
