Registrant has agreed to provide logistical support to the foreign principal, who will lead a delegation to participate in the International Leaders Forum, organized by the National Democratic Institute, in conjunction with the Democrat National Convention in Charlotte, NC in September. The foreign principal will then travel to Washington DC for bilateral meetings with officials of the White House, Department of State, Department of Commerce, United States Senate and United States House of Representatives. Registrant will assist the foreign principal in organizing such meetings.
