On February 1, 2012, Sonangol SA agreed to fund both Progress for Angola, Inc., and Progressive Angola, Inc. in the amount of \$600,000 per organization (\$1,200,000 total) for the purposes of increasing the visibility of Angola in America, and to fund and run an effective reputation management and branding campaign for Angola. Both Progress for Angola and Progressive Angola agreed to run this campaign for one year, with the option to renew the agreement at the conclusion of the first year.

Progress for Angola, Inc., will run a reputation management and branding campaign on behalf of Angola, and will engage a public relations firm for advice and consultation on campaign management.
