We have written letters to European, US and the UN on human rights abuses in Laos, including the recent case of the freedom fighter, Mr. Moua Toua Ther, being sent back to Laos from Thailand in June, 2014.

We have also come to Washington, D.C. to lobby for Laos democracy and human rights from August 18-20, 2014 by talking to the Lao and Cambodia Desk Officer and some US Congressional leaders.

We have given speeches to Lao-Hmong-American organizations in MN, WI, IA, MI, NC, CA, Oklahoma, Arkansas and TX on political, human rights, social and veterans issues, including the recent Lao-Hmong T-28 Pilot Exhibit Dedication in Shegboygan, WI. on Sept. 20, 2014. Among the speakers are: President Chong Vang; Secretary-General Tou-Fu Vang; Vice-President Lo-Cam Oun; Col. Ly Teng, ULC Advisor; Col. Moua Gao, Chairman of MN/ULC; and Chao Khamlouang Nokham, President of the Supreme ULC Advisory Board.
