In the course of those efforts, Mr. Torricelli has communicated extensively with the State Department officials and on occasion with Congressional officials. The specific contacts are detailed in Attachment One. In addition, Mr. Torricelli participated in planning meetings and strategy sessions with leadership of the foreign principal.
