**CONSULTING AGREEMENT**

This Agreement is made on 6 April 2013 between Grayling (the "Company"), a company with its principal place of business at Office 337, Building 10, Dubai Media City, P.O. Box 24554 Dubai, United Arab Emirates and DUTKO WORLDWIDE LLC dba DUTKO GRAYLING a company with a principal place of business at 100M St. SE, #500 Washington, DC, 20003. The Contractor has extensive experience regarding services required by Fundo Soberano de Angola (Company's Client), a company with a principal place of business at Rua Ferreira Furtado, n°12, Cidade Alta - Caixa Postal 6869, Luanda, Republica de Angola, and the Company seeks to benefit from the Contractor's expertise by retaining the Contractor as an independent consultant. The Contractor wishes to perform consulting services for the Company. Accordingly, the company and the Contractor agree as follows:

**1. Scope of Services**

Contractor hereby agrees to render certain public-relations consultancy services at the direction of the Company in order to serve Company's Client. Specifically, Consultant has been retained to:

- Media relations - Securing media interviews organization
- Stakeholder program - Arranging stakeholder meetings with key organisations

Contractor shall use best efforts in the performance of all responsibilities and services, and warrant that such services shall be performed in the highest applicable professional standards.

**2. Fees and Expenses**

**(a) Fees**

As consideration for the consulting services provided by the Contractor, the Company shall pay the Consultant a flat fee of \$13,500.00, plus up to \$2,500 legal and compliance fees, and all approved out of pocket costs

**(b) Expenses**

Company authorizes the Contractor to incur and receive reimbursement for out-of-pocket expenses related to the Contractor's performance of the Agreement, including up to \$2,500 for legal and compliance-related expenses.

**3. Term and Termination**

(a) This agreement shall be effective beginning 6 April 2013 and shall continue until 26<sup>th</sup> April 2013.

**4. Prohibition on Gifts, Gratuities, and Certain Expenses**

During the course of performing his duties hereunder, Contractor shall not provide any gifts or gratuities to, nor purchase anything of value or incur any expense for, the direct or indirect benefit of any governmental employee, official, or staff member, or their families (regardless of jurisdiction). By the way of example only, prohibited expenses include (but are not limited to): meals, entertainment, beverages, and travel, provided to any governmental employee, official, or staff member of their families. The Company will not reimburse any such prohibited expenses if submitted for reimbursement and does not authorize the Consultant to make any such expenditures during the course of Consultant's duties hereunder.
