December 09, 2013 - literature review on methodological standards and challenges of estimating excess-deaths during periods of civil conflict. In this paper I summarized the seminal literature on the nature of the standard methodology accepted in the field using existing or projected census data, and/or sample surveys to estimate excess-deaths, as well as the standard methodology of survey sampling using best practice principles. I did not offer my opinion in this paper, but rather, summarized the consensus of authoritative the literature. The literature review summarizing key studies was submitted to the foreign principle on December 12, 2013.

On approximately December 6, 2013 I was contacted by the public relations officer at my university where I am employed as a part-time faculty member in response to a query she received seeking an email interview with a professor who has researched the Rwandan genocide. The questions pertained to the role of propaganda before, during and after the Rwandan genocide. My responses (which are attached) were limited solely to my dissertation and were offered within the capacity of my faculty position at my university, and had no relationship whatsoever with the government of Rwanda, nor were my responses offered on behalf of Rwanda, nor did I consult Rwanda about the nature of my responses. My responses may benefit the government of Rwanda because my research highlights the role of current propaganda disseminated by Rwandan exiles in denying the 1994 genocide, yet whether this benefits of the government of Rwanda is impossible for me to determine definitively.
