Sandler Trade LLC advocated for passage of the Nepal Trade Preferences Act (S. 81). Advocacy activities include:

- 1) Communicating via telephone and email with Congressional staff
- 2) Meeting with Congressional staff to discuss S.81
- 3) Contacting Association of Nepalese Americans to explain the benefits S.81 and to persuade them to support the Bill
- 4) Disseminating information in support of S.81
