Description of Activities: Registrant has been retained by the foreign principal for activities that do not require reporting under FARA, including representation of Kuwaiti detainees held at Guantanamo Bay, Cuba. In connection with this representation, Registrant has engaged in litigation on behalf of Kuwaiti citizens detained at Guantanamo, styled Fawzi Khalid Abdullah Al Odah v. United States of America, et al., Case No. 13-cv-1420 (CKK), United States District Court for the District of Columbia. Registrant has also participated in meetings with representatives of the Executive Branch, which are described more fully in response to Question 12 and Attachment 1.
