Registrant has been retained by the foreign principal for activities that do not require reporting under FARA, including representation of Fayez Al Kandari, a Kuwaiti citizen held at Guantanamo Bay, Cuba. In connection with this representation, Registrant has engaged in litigation on behalf Mr. Al Kandari styled Fayez Mohammed Ahmed Al Kandari v. United States of America, et al., Case No. 15-cv-329 (CKK), U.S. District Court for the District of Columbia. Mr. Al Kandari's case was appealed to the D.C. Circuit (Fayez Mohammed Ahmed Al Kandari, Appellant v. United States of America, et al., Appellees, Case No. 15-5268, U.S. Court of Appeals for the D.C. Circuit). The District Court and Circuit Court cases were recently dismissed by the D.C. Circuit due to Mr. Al Kandari's repatriation to Kuwait. Registrant continued representation of Mr. Al Kandari in the Periodic Review Board process until his repatriation to Kuwait on January 8, 2016. Registrant has also participated in meetings with representatives of the Executive Branch, which are described more fully in response to Question 12.

Lewis, exchanged e-mail correspondence with Charles Trumbull, Acting Special Envoy for the Closure of Guantanamo Bay, U.S. Department of State on November 12, 2015, December 1, 2015 and December 9, 2015. The correspondence concerned U.S. policy with respect to the continued detention at Guantanamo Bay of Kuwaiti citizen Fayez Al Kandari.
