DuSable has continued to take steps to promote itself, Malaysia, and Malaysia-related business opportunities in order to develop additional business for DuSable, but those efforts have not borne fruit to date. As noted elsewhere, DuSable has sold its interest in the solar project on which it sought non-financial support from the U.S. government.

On October 2, 2014, the private equity fund managed by DuSable entered into an agreement to sell its joint venture interest in the solar project to 1MDB in anticipation of an initial public offering of 1MDB's energy assets. Proceeds of that sale have been and will be distributed to DuSable and its limited partners pursuant to the fund's subscription agreement and other agreements with the limited partners.
