The term of the agreement shall be for 12 months and will commence when funding has been arranged. This is the entire agreement as of this date.

Cornerstone Government Affairs will serve as the day-to-day manager of the LNG Allies coalition. Cornerstone will also provide federal advocacy services for the coalition and supervise a media relations subcontractor. Cornerstone will produce written and electronic materials in support of the coalition and maintain a public website. Cornerstone will also supervise subcontractors who will manage conferences and events for the coalition.

LNG Allies will advocate for the free, fair, and expedited trade of natural gas and other energy resources between the United States and our allies around the world.
