I use public sources and also primary sources from discussions of politics with contacts due to professional and personal interests that do not require FARA registration. I do not make phone calls to campaigns and government office personnel to influence policy. I attend grassroots events, local campaign events and other Democratic and Republican events in NH where I meet with candidates and elected leaders at the state and federal levels.
