**Article 4 Company's Responsibilities:** To perform all activities guaranteed in compliance with the protocol.

**Article 5 Company's Activities:**

- Publication of newspaper ads.
- Promotional video placement on a video wall in Times Square.
- Furnishing the conference room and catering service, providing the necessary staff.
- Providing local and airport transportation.
- Providing the visual materials for the conference.
- Conducting media outreach for the conference.
- Performing other activities as necessary for the event.

**Article 6 Documentation of Expenses and Reimbursement of the Company:**

- All expenses shall be documented by invoices and other valid forms of expense documents.
- Invoices and receipts of all expenses shall be given to the Company by the Association and the Company will be reimbursed for these expenses.


**Article 7 Disagreement with the Protocol:**
