

ARTICLES OF ORGANIZATION

OF

PARK STRATEGIES, LLC

(Under Section Two Hundred Three of the Limited Liability Company Law)

The undersigned person, acting as an organizer of the limited liability company hereinafter named, sets forth the following statements.

FIRST: The name of the limited liability company (the "Company") is Park Strategies, LLC.

SECOND: The county within the State of New York in which the office of the Company is to be located is the County of New York.

THIRD: The latest date on which the Company is to dissolve is December 31, 2048.

FOURTH: The Secretary of State of the State of New York is designated as agent of the Company upon whom process against it may be served.
