

The Registrant is negotiating a contract with the Foreign Principal. The Registrant has suggested a monthly retainer of \$3,500 plus reimbursement for out of pocket expenses. The Foreign Principal has suggested a monthly retainer of \$3,500 per month in 2014 and \$3,000 per month thereafter. Because the Registrant is confident that the parties will come to agreement and will execute a contract soon, the Registrant has begun work for the Foreign Principal.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The objective of the representation will be to preserve Nicaragua's current benefits under the U.S.-Central America Free Trade Agreement. Representation will involve the provision of strategic counsel and planning on trade policy matters to the Government of Nicaragua, Corporation de Zonas Francas. Representation will also involve outreach to relevant U.S. government entities (including the U.S. Congress, the U.S. Department of Commerce, the Office of the U.S. Trade Representative, and the U.S. Department of State) and relevant private sector stakeholders (particularly apparel brands, textile companies, and retailers with an interest in Nicaragua). Finally, representation will include the drafting of background materials, statements, and letters to and for the above mentioned entities, explaining the operation of and merits of Nicaragua's current benefits under the U.S.-Central America Free Trade Agreement.

The representation will include providing strategic counsel and planning on trade policy matters before the U.S. Government and industry associations.

Barnes & Thornburg LLP will meet with the trade policy officials in the U.S. Government regarding the maintenance of Nicaragua's current benefits under the U.S.-Central America Free Trade Agreement in an effort to keep Nicaragua's trade benefits from expiring. Barnes & Thornburg LLP will also communicate with affected industry associations regarding the aforementioned effort.
