The registrant will provide consulting services which shall include assistance in contacts with the U.S. Government, diplomatic missions, news organizations, U.S and other companies wishing to do business in Al Anbar Governorate and oher areas of Iraq. The registrant has set the fee at \$25,000/mnth, exclusive of expenses, once the project is funded. A copy of the Representation Agreement signed by the foreing principal is attached.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant will provide consulting services which shall include assistance in contacts with the U.S. Government, diplomatic missions, news organizations, U.S and other companies wishing to do business in Al Anbar Governorate and oher areas of Iraq. This will entail meetings with U.S. Government entities as well as private sector interests.

The registrant will be promoting the creation of a Semi-autonomous region for the Sunni tribes in the Anbar region and other regions in Iraq. This will entail contacts with U.S. Government officials. The current policy which the registrant is seeking to influence is the reluctance of the U.S. Government to support a semi-autonomous region.

REPRESENTATION AGREEMENT

This confirms the appointment of JONATHAN S. GREENHILL and the GREENHILL GROUP LLC to act as the exclusive representatives for myself, individually, and for those whom I represent, for the purpose of promoting the creation of a Semi-autonomous Region, commercial ventures for the Sunni tribes in Iraq and any work related thereto, effective immediately. Specifically, Mr. GREENHILL and the GREENHILL GROUP LLC shall serve as our exclusive representatives for all contacts with the U.S. Government, the diplomatic missions of the countries comprising the Gulf Coordination Council, and other diplomatic missions as agreed. In addition, Mr. GREENHILL and the GREENHILL GROUP LLC shall serve as our exclusive representatives for all contacts with U.S. corporations and companies and those with U.S. affiliates wishing to do business in Al Anbar Province and those other Sunni provinces as designated by the undersigned, with U.S. news organizations seeking contact with me and with other entities as directed.

All previous agreements that may affect the work of Mr. GREENHILL and the GREENHILL GROUP LLC are hereby revoked.

Representation of the undersigned, individually, and those whom I represent, by JONATHAN S. GREENHILL and the GREENHILL GROUP LLC, is for an initial period of 12 months, effective immediately. Subject to agreement of the parties, it shall renew for a period of 12-months unless either party has given the other, by letter, fax or email, at least 30-day advance written notice of its revocation.
