This has entailed meeting with members of congress and their staffs to engage them in discussions on the destruction of ISIS, the need to establish an autonomous region for the Sunnis within Iraq, to stabilize eventually western Iraq for foreign investment and to block the growing influence of Iran in Iraq. I also discussed direct aid to the Sunnis of Iraq by the U.S.
