The Federal Republic of Nigeria has hired an affiliate of the registrant located in London, England, CMGRP UK Limited d/b/a Weber Shandwick (WSUK), to provide public relations, strategic communications and lobbying in the United Kingdom, the United States and/or Nigeria. WSUK has hired the Washington, DC office of CMGRP, Inc. d/b/a Weber Shandwick (Registration No. 3911) (WSDC) to create a website ([www.nigerianext.com](http://www.nigerianext.com)) to promote Nigeria's Transformation Agenda. WSDC has hired the registrant to help develop content for the website. The work assigned to the registrant and the budget are described in more detail in response to Question 8 below.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant has been hired by WSDC to research issues, develop website content and interview business executives and public figures on film to create website content. The registrant may respond to inquiries about the website from the press or others, including government officials. The registrant has been given a budget of \$83,000, which includes all fees and expenses.
