

Footnote: "Political activity," as defined in Section 1(o) of the Act, means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

Contract:

Mr. Tamaki Tsukada, Minister and Head of Chancery at the Embassy of Japan (hereafter referred to as A), acting on behalf of Japan and in accordance with the authority vested in him or her and Greenfield & Kress PA (hereafter referred to as B) have agreed as follows with respect to certain activities to be provided by B:

1. B pledges to provide, upon request from A, advice and assistance in connection with the normal business of the Japanese Embassy (or Consulate) and other matters as required, as well as information of relevance.
2. The period of the contract shall be from April 1, 2015 to March 31, 2016.
3. The fee for service shall be \$30,000 per year. A shall pay B \$7,500 at the end of each quarter.
4. B must not divulge any confidential information learned through association with A, neither during nor after the period of this contract, unless required to do so by law.
5. This contract may be renewed prior to the expiration for a further period of one year by agreement between both parties.
6. Notwithstanding the foregoing provisions, either party may cancel this contract by issuing notification 30 days in advance.
