Roughly thirty (30) individuals from Japan will visit the U.S. over the course of 12 months during the calendar years of 2015 and 2016, and, for each individual, McBee Strategic will be expected to arrange several meetings with American intellectuals, think tank organizations and scholastic institutions across the country, although primarily in Washington, DC. The intent is to foster better understanding and stronger relationships between the United States and Japan. The engagement will span 12 months during the calendar years of 2015 and 2016, and a fee of Eighty Thousand dollars (\$80,000) will be received.


