(As responses to questions 7 and 8 of that exhibit indicate, Omni Advisors will seek debt relief for Sudan by negotiating with multilateral, bilateral, and commercial creditors of Sudan. As the response to question 9 of the same exhibit further indicates, the potential activities in support of that work may include contacts with members of the U.S. Congress, U.S. Executive Branch personnel, other governments, public multilateral organizations, media outlets, and "think tanks.")

As noted previously in question 8 of the initial registration form, the Law Office of Bart S. Fisher provides legal services to the Embassy of Sudan under a separate OFAC license.
