Dr. Mudhar Shawkat - Registrant assisted the Foreign Principal in requesting meetings with the U.S. Congress (both House and Senate); accompanied Foreign Principal to scheduled meetings during July 2015 visit to DC. Registrant coordinated and provided information on Foreign Principal to Fox Broadcasting for an interview conducted by Greta Van Susteren. Provided background information and op/ed from Dr. Shawkat to a few news outlets and one think tank. Assisted Foreign Principal with the production and distribution of his personal newsletter (2 issues) regarding how to stop ISIS/ISIL in Iraq. Discussed and investigated the possibility of a congressional hearing for Dr. Shawkat to present his strategies but efforts were tabled due to time constraints. Registrant assisted Dr. Shawkat on a pro bono basis with invitations he extended to key congressional offices to attend a refugee conference in Erbil on November 7. (Our efforts consisted of follow-up emails made on his behalf.) Please see previously filed Registration and Dissemination/Activity Reports reported to FARA for the majority of activity shown above. 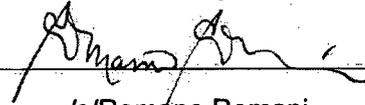
