





Nineveh Plain Defense Fund Launches to Provide Direct Legal Funding to the Nineveh Plains Protection Units

Chicago, IL, June 27, 2016– The Nineveh Plain Defense Fund (NPDF), proudly announces their public launch on Monday, June 27th with the release of their website: ninevehplaindefensefund.org.

The Nineveh Plain Defense Fund is a non-profit corporation, formally established in 2016 to provide direct, legal funding to the Nineveh Plain Protection Units (NPU). The Nineveh Plain Protection Units were established in 2014 by the Assyrian Democratic Movement after the invasion of Mosul and the Nineveh Plain by the Islamic State. In March, 2016, the Nineveh Plain Protection Units officially joined the Nineveh Liberation Operation Command, the campaign being led by the Government of Iraq to defeat the Islamic State and liberate Nineveh and other occupied territories. The long-term goal of the Nineveh Plain Protection Units is to ensure the long-term safety of these Assyrian lands for resettlement and repatriation of Assyrians to the Nineveh Plain.

The leadership of the Nineveh Plain Protection Units called for the creation of a direct funding organization and worked with Assyrian activists to create the Nineveh Plain Defense Fund. The Defense Fund now launches after a year of preparations to ensure its activities comply with US laws. The Defense Fund shall provide support for:

- Stipends for part-time reservists to augment the NPU's full-time force.
- Non-munitions equipment and supplies.
- Base infrastructure.

Our goal is to support the well-being of the men and women who serve and protect the Assyrian people and their indigenous land.
