The agreement reached orally with the Embassy of New Zealand is for one month of government affairs and political consulting services primarily focused on assisting the Embassy with its efforts to articulate New Zealand's support for the Trans-Pacific Partnership Agreement (TPP). The consulting services are likely to include arranging meetings with federal and state officials and organizing events with a focus on TPP. The consulting services are also likely to include arranging meetings with federal and state officials in relation to the Embassy's efforts to promote the candidacy of Helen Clark for the position of United Nations Secretary-General. The monthly fee for services is \$19,500, and the Embassy has an option to renew monthly.
