It is anticipated that some of these services may be provided to assist Saudi Aramco and the Government of the Kingdom of Saudi Arabia in investment outreach and public relations activities to help promote economic activity and cultural understanding with Saudi Arabia. Compensation for such services shall comprise reimbursement of the costs incurred plus a fee equal to 5% of those costs, as set forth in the attached agreement.
