Occasionally, representatives of the missions of Arab governments to the United States use Registrant's conference room to meet, but Registrant engages in no reportable activity in connection with such meetings.

Also, I was interviewed over the phone by the VOA, BBC, ANA (Arab Network of America). Also, I appeared on ANA T.V. on December 23, 1993. In these interviews I advocated the peace in the Middle East and the signing of the Declaration of Principals between the P.L.O. and Israel.
